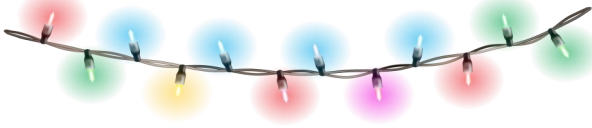

## SNOW REMOVAL

Snow removal occurs in the **Patio, Village, Manor, Garden and Prairie Meadows Homes** when snow accumulation on the ground reaches 1-inch wet or 2-inches dry from one or more snowfalls and snow removal will continue around the clock if necessary. Courts will be opened first then the parking spaces and driveways. If you knock down a snow stake, let the WMC office know.
